# *Nancy Steen Award 2005*

## **CRITERIA:**

- The National Executive of HRNZI shall assess all such nominations, and may, during their three-year term in office, make one award to a recipient who fulfils the above criteria.
- The Executive decision shall be binding, and no correspondence shall be entered into regarding decisions made.
- The award shall take the form of a plaque, and shall be funded by the "Nancy Steen Fund" as held by the National Executive.
- The award shall be presented at a National or International event held by HRNZI, and the recipient's name(s) published in the HRNZI Journal and website.
- These criteria may be varied from time to time, but the title and purpose of the award shall remain unchanged.

- The award shall take the form of a cast iron plaque, and be funded by HRNZI.
